- 2 The California Department of Education (CDE) reports a measure of “College/Career Readiness.” CDE reports the measure as an indicator of “the number of high school graduates who are prepared for college or a career” and it defines readiness as “completing rigorous coursework, passing challenging exams, or receiving a state seal.” CDE uses the college/career indicator to assign graduating high schools’ students to one of the following three categories: “prepared,” “approaching prepared,” or “not prepared.” California high school graduates are determined to be “Prepared” for a college or career by the state of California if they attain any one of the eight criteria outlined by the California Department of Education. This table presents the number of high school graduating students included in the calculation, the number and percentage of graduating students who were identified as “Prepared,” and the number and percentage of graduating students who were identified as “Prepared” because they met the “a-g completion” requirement. The state designates students as “Prepared” via the “a-g completion” requirement if they complete required courses to apply to California public universities with a C minus or better and complete one of the following: pass Smarter Balanced Summative Assessments with a level 3 or higher in english language arts/literacy and at least a level 2 in mathematics, or a level 3 or higher in mathematics and at least a level 2 in english language arts/literacy; complete one semester/two quarters/two-trimesters of college credit courses with a grade of C- or better in either academic or career technical education subjects where college credits are awarded for each course; achieve a score of 3 on one Advanced Placement (AP) exam or achieve a score of 4 on one International Baccalaureate (IB) exam; or successfully complete a career and technical education pathway. Summit Public Schools’ students predominantly achieve California’s “Prepared” designation for College and Career readiness by completing coursework over which Summit Public Schools has control. - 2 Washington State Charter School Commission's Performance Framework Reports for Summit Public Schools include a "school-specific goal" that estimates college readiness, which is defined in the report as "90% of students finish the year college ready by scoring at least 70% or higher in all classes. At least 50% of students exceed basic college readiness by scoring 85% or higher in all classes." This statistic is not a metric collected or published by the Washington Office of Superintendent of Public Instruction. The measure was proposed by Summit Public Schools to the Washington State Charter School Commission as a "school-specific goal." This statistic includes students who are graduating and students who are not graduating.

The "school-specific goal" that measures college readiness is used to place Summit Public Schools in Washington into one of the following categories:

1. Exceeds Standard: 95% of student finish the year college ready by scoring a 70% or higher and/or by having more than 60% of student meet the higher bar of college readiness by finishing the year scoring 85% or higher in all classes.
2. Meets Standard: 90% of students finish the year college ready by scoring at least a 70% or higher in all classes. At least 50% of students exceed basic college readiness by scoring 85% or higher in all classes.
3. Does Not Meet Standard: Summit does not meet standard if Summit achieves one of the following goals but does not meet standard on the other.
4. Falls Far Below Standard: Summit students do not meet standard on both goals.
